



# Radiologic Technology Information Sheet

## Admission Requirements

- 1. Complete and have on file a Copiah-Lincoln Community College official application.
- 2. Complete Radiologic Technology (RGT) Application and return to the RGT program.
- 3. Submit your transcript to the Office of Enrollment Services from an accredited high school showing graduation, or GED equivalency, or a transcript from previous college attended:

- 4. ACT score must be on file in the Office of Enrollment Services. *Composite score of 18 required.*
- 5. Submit two letters of recommendation. Recommendation forms can be found in Canvas.
- 6. Watch Video in Canvas and take the quiz.
- 7. Selection is based on RGT application packet, GPA, ACT score, and an interview.
- If selected, participate in drug and alcohol testing and criminal history background check.

*\*Admission to the program is on a competitive basis. The Co-Lin Radiologic program accepts a limited number of students for each fall semester. Selection is based on completed RGT Application Packet, ACT, GPA, and an interview. Must be 18 years or older upon entrance into the program.*

Dear Radiologic Technology Applicant:

Thank you for your interest in the Copiah-Lincoln Community College Medical Radiologic Technology program (RGT).

The Medical Radiologic Technology program is a two-year technical program designed to prepare graduates for employment as a radiologic technologist or radiographer. The radiographer uses equipment that emits ionizing radiation to image internal structures of the body. Employment opportunities include various health care facilities such as hospitals, doctors' offices, medical clinics, imaging centers, and sports medicine clinics.

The program provides an excellent foundation for obtaining higher level degrees of study or placement into advanced specialty imaging or treatment modalities in the healthcare field. Examples of advanced areas for registered technologists include ultrasound, CT, MRI, cardiovascular-interventional radiography, mammography, nuclear medicine, radiation therapy, administration, and education.

The RGT curriculum includes technical and academic courses. Classroom and laboratory activities are conducted on Copiah-Lincoln Community College's Wesson Campus and clinical experience is gained at affiliating hospitals. Upon successful completion of the program the student is awarded an Associate in Applied Science degree in Medical Radiologic Technology, is eligible to apply for a state license and write the American Registry of Radiologic Technologist (ARRT) exam.

The Medical Radiologic Technology program is accredited by the Joint Review Committee on Education in Radiologic Technology.

The program enrollment is limited to twenty (20) new students each year. In addition to meeting college admission requirements, students are responsible for completing the items below in order to be considered for enrollment.

The applicant must:

1. Be **18** years of age upon entrance into the program.
2. Complete the Radiologic Technology Application to the **RGT** program by **February 1**.
3. Complete the college application and return to the **Co-Lin Enrollment Services Office by February 1**, unless a current Co-Lin student.
4. Provide evidence of high school graduation or equivalent to the Co-Lin Enrollment Services Office by **February 1**.
5. Have official college transcripts of all other college (other than Copiah-Lincoln Community College work) sent to the Enrollment Services Office by **February 1**.
6. Have ACT score on file in the Enrollment Services Office by **February 1**.  
The program requires an ACT score of eighteen (18) or above.
7. Have two letters of recommendation on file in Radiography program by **February 1**. The forms can be found in Canvas.
8. Watch the video in Canvas and take the quiz.

Acceptance into the program will be based on:

- Completed RGT Application Packet
- ACT score
- GPA
- Interview

If accepted, applicants participate in drug and alcohol testing and a criminal history background check.

The Medical Radiologic Technology curriculum includes specific radiography (RGT) courses and seven academic courses. **Students are required to have a “C” average in all course work.** The academic courses are listed below. Students completing the academic courses prior to being selected into the program are at advantage because bonus points are given for completion of Radiography curriculum academics completed with an “A” or “B” and used in the selection process.

## **CRIMINAL BACKGROUND INFORMATION**

All Health Science students who will be providing direct patient care in health care institutions regulated by the MS Department of Health should be aware that Mississippi law requires background checks for individuals seeking employment in a health care facility.

According to the Mississippi State Law, an individual may not be eligible for employment in a health care agency if the criminal history record check discloses a felony conviction, guilty plea or plea of nolo contendere to a felony of possession or sale of drugs, murder, manslaughter, armed robbery, rape, sexual battery, sex offense listed in Section 45-33-23 (f), child abuse, arson, grand larceny, burglary, gratification of lust or aggravated assault, or felonious abuse and/or battery of a vulnerable adult that has not been reversed on appeal or for which a pardon has not been granted.

Medical Radiologic Technology students are required to participate in a criminal background check **after acceptance** into the RGT program. All charges or convictions **must** be reported to the Radiography program in order for students to be cleared to take registry. The certifying agency for Radiologic Technologist (ARRT) requires reporting of all charges except minor traffic citations and convictions processed in juvenile court

**Once accepted into the program, it is the student's responsibility to immediately notify the RGT department in writing of any subsequent changes in criminal history that occur after the Criminal Background Check has been completed. Failure to do so may result in immediate withdrawal from the program.**

Students assigned to certain clinical affiliates may also be required to have **additional criminal background checks to comply with specific clinical affiliation guidelines.**

Students must be able to attend clinical affiliation sites in order to meet the requirements of the RGT Program. If a student is found to be ineligible for clinical placement any time during the program, the student is unable to meet clinical learning objectives and will be withdrawn pending resolution of the situation.

I hereby give permission for Copiah-Lincoln Community college to conduct background checks with the Mississippi Department of Public Safety, Federal Bureau of Investigation, and any other persons to determine my suitability in working in Health Occupations. Criminal background checks will be performed after entrance into the program, but prior to clinical placement.

Falsification of any information on this application will constitute grounds for non-acceptance into this program or dismissal from the program if applicant has been accepted.
