 - BIO 2513: Anatomy and Physiology I must obtain a grade of "C" or above
 - o BIO 2511: Anatomy and Physiology I Lab must obtain a grade of "C" or above
 - o BIO 2523: Anatomy and Physiology II must obtain a grade of "C" or above
 - o BIO 2521: Anatomy and Physiology II Lab must obtain a grade of "C" or above
- □ 7. Interview with instructor and/or committee
- 8. Submit Completed Health Occupations health certificate signed by a medical doctor
- □ 9. If accepted, all applicants must participate in a drug and alcohol testing and a criminal history background check
